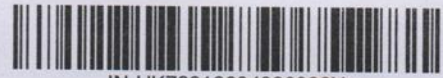

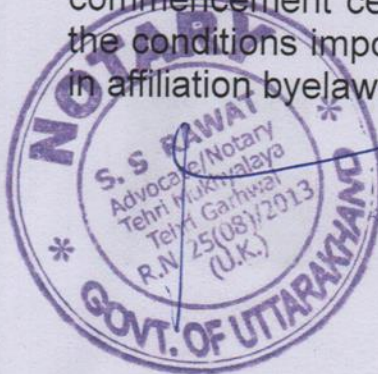
1. That Christo Indian Educational Society is a registered Society under the Society Registration Act 1860.
